### ELIGABLILITY:

Any swine exhibitor in 4-H, FFA, Independent, or Grange who meets all requirements below.

### RULES APPLYING TO THIS ENTRY:

1. The animal being shown MUST have been born in Shasta County.
2. The dam of the animal being shown MUST be a "resident" of Shasta County 30 days prior to conception of the animal being shown. The definition of "resident" shall be: The dam of the animal being shown shall either be incorporated into an established Shasta County herd or owned by an individual who resides in Shasta County. The sire of the animal being shown must have physically been in Shasta County at the time of conception or AI must be used. The dam cannot have been taken out of the county to be bred.
3. By signing this proof of eligibility from the breeder and the exhibitor agree to provide the following information in order to compete and be recognized in the Shasta District Fair Bred and Fed program.
4. Along with the certifications below, you must turn in a copy of a bill of sale.
5. By signing this proof of eligibility form the breeder and the exhibitor agree to provide the following information in order to compete and be recognized in the Shasta County Bred and Fed Competition.
6. The Shasta District Fair is opposed to violation of the rules and will deal with violators in a lawful manner. In the event of a violation is deemed true, exhibitors will lose all premiums and awards. Breeders will lose the privilege to compete in the Shasta Bred and Fed program.
